Transferring an Administrative Certificate (Principals and Superintendents) from Texas to Other States

Individuals who acquire a Texas administrative certification (i.e. principal and/or superintendent) and who wish to serve as an administrator in the public education system of another state may be required to meet additional requirements. These requirements may include additional assessments by the host state. Also, in some states, additional coursework may be required. In some instances, however, the additional coursework and assessments are waived for individuals who have experience in the state from which the certificate was issued. Because requirements are different for each state, it is essential that candidates contact the Department of Education in the state to which they are moving to verify that the information contained in the websites below is accurate, comprehensive, and has not changed after the chart was created. School Leader Certification and Preparation Programs

<u>General Information - What are the requirements for school leaders licensed out-of-state?</u> <u>April 2018</u>

- **CAEP**: The Council for the Accreditation of Educator Preparation (CAEP) serves as a national accrediting body for educator preparation programs. CAEP was formed in 2013, with the consolidation of the National Council for Accreditation of Teacher Education (NCATE) and the Teacher Education Accreditation Council (TEAC).
- **NASDTEC**: The National Association of State Directors of Teacher Education and Certification (NASDTEC) Interstate Agreement facilitates license reciprocity in states which have signed the agreement. The agreement outlines which forms of licensure will be accepted by the 'receiving state' and under what conditions.
- **ISLLC/PSEL Standards**: The Interstate School Leaders Licensure Consortium (ISLLC) Standards are nationally recognized school leadership standards first developed in 1996 and revised in 2008 and 2015. The 2015 version of the standards was renamed Professional Standards for Educational Leaders (PSEL).
- **ELCC Standards**: The Educational Leadership Constituent Council (ELCC) Standards are nationally recognized educational leadership program standards. These standards were revised in 2018 and renamed The National Educational Leadership Preparation (NELP) Program Recognition Standards.

<u>Specific Information</u> - The data included in this 50-state comparison is specific to school leader preparation program and certification requirements.
