AN ORDINANCE CREATING AND INSTITUTIONALIZING THE TUTORIAL AND STAFFING REQUIREMENTS OF THE PAMANTASAN NG LUNGSOD NG MUNTINLUPA (PLMUN) AND APPROPRIATING FUNDS THEREFOR.

WHEREAS, Section 458(a) of the Local Government Code of 1991 provides that, "the Sangguniang Panlungsod is empowered to create and determine the positions, salaries, wages, and other emoluments and benefits of officials and employees, paid wholly or mainly from the City Funds and provides for the expenditures necessary for the proper conduct of program, projects, services and activities of the City Government;

WHEREAS, Article 99 of the Implementing Rules and Regulations of the Local Government Code of 1991 further provides that, "the Sangguniang Panlungsod as the Legislative Body of the City, shall enact ordinances, approve resolutions, and appropriate funds for the general welfare of the city xxx;

WHEREAS, Article 163 of the Implementing Rules and Regulations of the same Code provides that, "the local government unit shall design and implement its own organizational structure and staffing pattern, taking into consideration its priority needs, service requirements, and financial capabilities, consistent with the principles of simplicity, efficiency, economy, effectiveness, dynamism, and public accountability subject to the minimum standards and guidelines prescribed by the Civil Service Commission (CSC)

WHEREAS, Articles 164 (a) of the same Code, likewise provides that, any local government unit may be reorganized through the Sanggunian, its present organizational structure or alter its present staffing pattern in accordance with laws pertinent to government reorganization and implementing rules and regulations xxx;

WHEREAS, on March 20, 2003, the Sangguniang Panlungsod enacted City Ordinance No. 03-089 there by creating the Charter of the Pamantasan ng Lungsod ng Muntinlupa (PLMUN) and converting the Muntinlupa Polytechnic College (MPC) into a local university;

WHEREAS, inherent to its operations as a university and an institutional of higher learning, it is imperative to institutionalize the working force of the Pamantasan ng Lungsod ng Muntinlupa City (PLMUN) which is made up of the academic and non-academic personnel;

WHEREAS, as shown in the organizational structure of Pamantasan ng Lungsod ng Muntinlupa (PLMUN) the Office of the University President, the Office of the Vice-President for Academic Affairs and the Office of Vice-President for Administration and Finance are the three (3) major Offices, and the staffing requirement of which need to be institutionalized;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the Sangguniang Panlungsod of Muntinlupa in session assembled that:

SECTION 1. *Title* – This ordinance shall be known as the creating and institutionalizing of tutorial and staffing requirements of the Pamantasan ng Lungsod ng Muntinlupa (PLMUN) under the Office of the Mayor and appropriating funds thereof.

SECTION 2. *Mandate* – The City Personnel Office is hereby mandated and shall see to it that the positions to be created and institutionalized at the PLMun is in accordance with the qualification standards of the Civil Service Commission (CSC).

SECTION 3. Composition – The Pamantasan ng Lungsod ng Muntinlupa shall be composed of the following position, number of positions to be filled-up salary grade and the total basic annual salaries are hereby created and institutionalized according to staffing requirements as prescribed in Budget circular No. 2004-3A, "Conversion Of Positions Performing Staff/Non-Technical Function".

SECTION 4. *Appropriations* – Inherent to the implementation of this Ordinance which is however, subject to further evaluation and approval of both the Civil Service Commission (CSC) and the Department of Budget and Management (DBM), the appropriation of Thirty Five Million Three Hundred Eleven Thousand Five Hundred Forty. Pesos and Eighty Four Centavos (Php 35,311,540.84) of the Pamantasan ng Lungsod ng Muntinlupa (PLMUN) is hereby set aside to pay the basic salaries, wages and other emoluments and benefits of officials and employees who may be appointed or designated for the positions above, the amount of which shall be drawn from the General Fund of the Pamantasan ng Lungsod ng Muntinlupa (Abstract of detailed computation is herewith attached to form as integral part of this Ordinance).

SECTION 5. *Implementing Guidelines* – The Pamantasan ng Lungsod ng Muntinlupa (PLMun) shall formulate the Implementing Rules and Regulations for this purpose and shall submit its staffing pattern to the City Personnel Office for its approval.

SECTION 6 Separability Clause – If any position in this Ordinance is declared invalid, the remainder of this Ordinance shall not be affected by such declaration and shall remain valid and enforceable.

SECTION 7. *Repealing Clause* – All ordinances, rules and regulations or parts thereof where provisions are in conflict with or contrary to the provisions of this Ordinance are hereby repealed, amended, or modified accordingly.

SECTION 8. Effectivity Clause – This ordinance shall take effect upon its approval.
